On a motion by Commissioner Haskin, seconded by Commissioner Haynak, and carried unanimously, it was moved to appoint Commissioner Michael Duggan as Board Chair for 2018.

On a motion by Commissioner Haskin, seconded by Commissioner Haynak, and carried unanimously, it was moved to appoint Commissioner Richard Haynak as Board Vice-Chair for 2018.

The minutes of the December 6, 2017 regular meeting were read and approved as read.

The fund balance report was presented, discussed and invoices were reviewed.
