## CLARE COUNTY ROAD COMMISSION

Minutes of the regular meeting of the Board of County Road Commissioners of Clare County, Michigan, hereinafter referred to as the Board, held at its office at 3900 East Mannsiding Road, Harrison, Michigan on August 15, 2012.

The meeting was called to order at 9:00 a.m. by Chairman Michael Duggan with Commissioners Richard Haynak and Eddy Garver in attendance. Staff present was Ron Bushong, Manager; and Kim Kimmel, Finance Director.

## Pledge of Allegiance

Guests present were Richard Wells, Freeman Township Trustee and Jane Walters, Franklin Township resident.

The minutes of the August 1, 2012 regular Board meeting were read and approved as read.

The fund balance report was presented and discussed and bills were reviewed. On a motion by Commissioner Duggan, seconded by Commissioner Haynak and carried unanimously, it was moved to approve for payment payroll ending 08/05/12 (checks 49263-49289), check for FICA, July MERS and AP checks 64652 thru 64694 totaling \$144,387.92.

Jane Walters, Franklin Township resident, addressed the Board regarding a grading issue on Claroskee Road and Athey Avenue.

The County Road Association Self-Insurance Fund meeting will be held on September 5, 2012 in conjunction with the Northern Michigan Association of Road Commissions Annual Conference. On a motion by Commissioner Duggan, seconded by Commissioner Haynak and carried unanimously, it was moved to appoint Manager Ronald Bushong as voting delegate and Eddy Garver as alternate voting delegate to represent the Commission at this meeting.

The MERS 66<sup>th</sup> annual meeting will be held October 3-5, 2012 at the Amway Grand Plaza in Grand Rapids, Michigan. On a motion by Commissioner Duggan, seconded by Commissioner Haynak and carried unanimously, it was moved to appoint Kathy Duynslager as voting officer delegate and Kimberly Kimmel as officer alternate delegate to represent the Board at this annual meeting.
